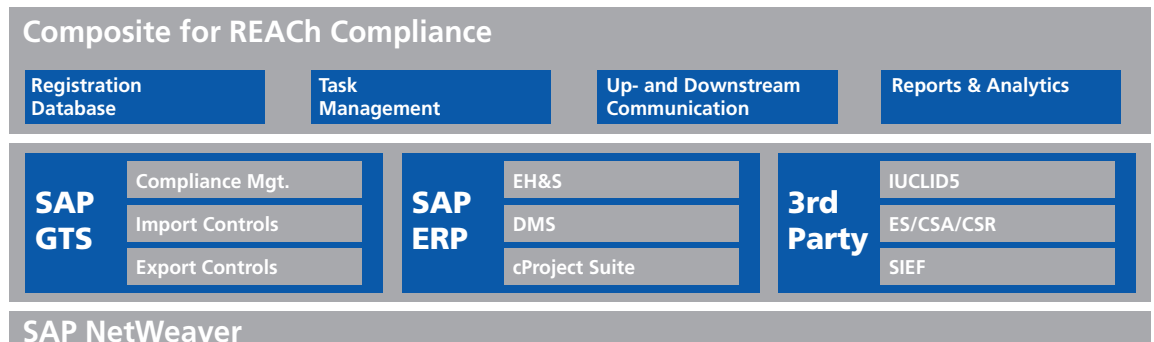

SAP offers a configurable interface to transfer relevant substance information from your SAP EH&S system into IUCLID 5 and/or to transfer substance information from IUCLID 5 into your SAP EH&S system. This enables companies to transfer substance data for registration purposes and guarantees that the data being sent to the European Chemicals Agency is consistent with the extended Safety Data Sheet as required by the REACH regulation. SAP Global Trade Services

SAP Global Trade Services (SAP GTS) Compliance Management integrates registration status information for chemical inventories as required by regulations such as REACH or the Toxic Substance Control Act (TSCA) in the US, thereby guaranteeing that legal requirements are met for purchasing and sales as well as for imports and exports. The integration of SAP EH&S enables SAP GTS to use existing master data. Automated compliance checks eliminate manual checks, enabling you to react faster to requests and to reduce cycle times to process logistical documents.
